This production received terrific reviews not only from the media, but from our spectators as well. For your reference, I have enclosed several letters we have received regarding our Centennial special production.

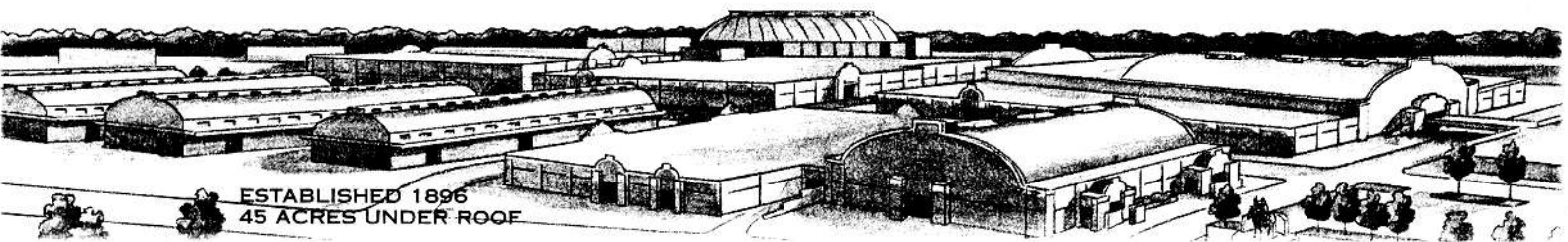
It is without reservation that I give an endorsement and recommendation to Tad Griffith and A Tad Western Production Company for his ability to produce an extravagant, entertaining production.
